Engendering Culture: The "Modern" Woman

A study of the way in which American culture is shaped by gender and how culture is constructed. In this course we will study: Victorian Marriage, Companionate Marriage and Modern Millies, Consumer Culture, Advertising and Leisure, Beauty Culture, New York Night Life, how corporate office work developed gender and racial codes, New Deal Art and Theater, militarization and gender, Cross dressing and the Double Life, Alcohol and gender, Men in Westerns, Divorce and the Anti-Feminist.

Seminars provide an excellent opportunity to explore a subject in depth. The reading in this course may therefore be heavier than you expected. Be sure to explore the assigned readings and understand your assignment before you begin reading. This seminar is designed to help you produce an honors quality paper. You will not be doing the same amount of work as an honors student, but you will have an opportunity to organize your thoughts around four or five monographs, tie them into the main reading for the week and lead discussion.

Due to the exceptional flu season and the close quarters of the seminar you are urged to get your flu shot before coming to class. You may have one unexcused absence if you do get the flu, this gives you a week to recover. Unless you are ill, do not miss a class as it will count against you in the final grade. Seminar papers.

In addition to the weekly reading you will be asked to read four to six other sources for your seminar paper, which is due in draft form during separate weeks of the semester. This paper should be 7-10 pages in length with 1-3 pages of annotated bibliography and should thoroughly explore the monographs and articles you have read as well as integrate this material into the common readings of the class. On Friday afternoon (2-5 pm) the week before your essay you will come to my office with a copy of your rough draft. You will choose your primary sources and copy them for the seminar. After you have done your revisions, you will email your essay to members of the class in advance on Sunday evening before 6 PM, at this time you will put a hard copy of the paper in the mailbox outside my office, 211 Trotter. **There are no late papers in this class**. You are urged to pick your topic after the first week and *begin reading for that week immediately*. You will need to read the main assigned reading first and proceed from there.

You will have a chance to revise your paper at the end of the semester and you are urged to take notes during the discussion of your paper in seminar for this purpose. Also, you will be responsible for helping a colleague revise their paper. (60%= 30 % original draft, 5% for your revision suggestions to other students and 25% for your revised paper) Finally, because this is a reading seminar, you are responsible for the common readings of the class; some of you will be designated as discussion leaders for classes. (15%) If you fail to have done the reading you will lose credit, which you may make up by diligently participating in subsequent classes. Nevertheless, if you do not keep up with the reading your performance in seminar may erode your graded paper work. (5%). It goes without saying that if you miss one session of the seminar, you have missed a weeks worth of work. Your grade will deteriorate accordingly.

The remaining (25%) of your grade will be based on the quality of your annotated bibliography. You will summarize your reading and add everything you have read to your bibliography, including book reviews. You are strongly encouraged to use the library's jstor database, which makes available 40 history journals, many of which have reviews of what you are reading. You are also encouraged to find your own primary sources copy and distribute them to your class and add them to your bibliography. Go to the American Memory project in the Library of

Congress or any one of a number of web sites and bring it to your Friday afternoon consultation.
